at Norwich until 1885, when he went to Sandusky, Ohio, thence to Chicago and from the latter city to Brooklyn, New York. His last days were spent in Hanover with his daughter, Mrs. D. C. Wells, and he died in that town in 1905. He was in early life a Whig in politics, and later a Republican. In his religious belief he was a Congregationalist, and as a young man he united with the church in Norwich. He was first married, September 4, 1837, to Sarah White Lester, of Griswold, who was born in December, 1817, daughter of Joseph and Martha (Coit) Lester. She died September 20, 1846, and on December 5, 1849, he married Julia H. Doolittle. She was born June 28, 1830, and died in 1860. The children of his first union are: William Jewett, now president of Dartmouth College, who will be again referred to. Elizabeth Coit, born July 28, 1844, died September 29 of that year; and Edward Jewett, born August 28, 1846, died February 22, 1863. Of his second marriage there is one daughter, Sarah Elizabeth, who was born March 18, 1854, and on June 2, 1887, became the wife of Professor D. C. Wells, of Bowdoin College.

(X) William Jewett, D. D., LL. D., eldest child of Henry and Sarah W. (Lester) Tucker, was born in Griswold, July 13, 1839. Upon the death of his mother in 1846 he was taken into the home of her sister, the wife of the Rev. William Reed Jewett, then pastor of the Congregational Church in Plymouth, New Hampshire, and was subsequently adopted into the family, receiving the legal right to insert the name of Jewett in his baptismal name. He prepared for college at the Kimball Union Academy at was graduated at Dartmouth with honor in the class of 1861. After devoting two years to teaching at Columbus, Ohio, he entered the Andover, Massachusetts Theological Seminary, from which he was graduated in 1866. From 1867 to 1875 he was pastor of the Franklin Street Congregational Church, Manchester, and from the latter year to 1879 he occupied the pulpit of the Madison Square Church, New York City, resigning that pastorate in order to accept the chair of sacred rhetoric at the Andover Theological Seminary, retaining that post until 1893, when he was unanimously elected president of Dartmouth College, and has ever since directed the affairs of that well known seat of learning.

While at Andover he founded the Andover Home, a Social Settlement in Boston, now known as the South End House. He was also one of the original editors of the *Andover Review*, the editorial writings of which Review gave rise to the "Andover Case." He was the Phi Beta Kappa orator at Harvard, 1802; lecturer in the Lowell Institute, 1804; Lyman Beecher lecturer at Yale, 1808; lecturer on the Morse foundation at Union Theological Seminary, 1902; and on the Earle foundation, Berkeley Divinity School, Berkeley, California, 1904. He is the author of "From Liberty to Unity," 1802; "The Making and Unmaking of the Preacher,"

(Second Family.)

TUCKER is an old English occupative surname and means weaver. The ancient Tucker families of New England are from several ancestors not known to be related to each other. This family was early planted in Massachusetts and New Hampshire.

(1) **Morris Tucker**, whose christian name in ancient records is often written Maurice, of Salisbury, Massachusetts, and Tiverton, Rhode Island, is of record as a "cooper." He was a householder in Salisbury in 1659, took the oath of allegiance and fidelity there in 1677, and became a freeman in 1690. He and his wife signed the Bradbury petition in 1692. He was of Salisbury in 1694, and of Tiverton, February, 1700. He probably moved to the latter town in 1699, as he deeded his real property there to Samuel Joy on February 3 of that year. On May 7, 1694, he deeded ten acres to his son James, for ten pounds. He married (first), October 14, 1661, Elizabeth Stevens, born in Salisbury, February 4, 1642, and died October 16, 1662, daughter of Sergeant John and Katherine Stevens; and (second), 1663, Elizabeth Gill, born January 8, 1646, daughter of John Gill. The only child by the first wife was Benoni. Those by the second wife were: John, Mary, James, Sarah, Joseph, Jabez, Elizabeth, and Morris. (Mention of Joseph and descendants appears in this article). Some of the descendants of this ancestor were Quakers.

(II) Benoni, eldest child of Morris and Elizabeth (Stevens) Tucker, was born in Salisbury, October 16, 1662, and was a weaver, living in Salisbury and later in West Amesbury. He signed the Bradbury petition in 1692; and was a "snow shoe man" in Amesbury in 1708. His will was dated January 14, and proven March 17, 1735. He married Ebenezer Nichols, born August 3, 1664, daughter of Thomas and Mary Nichols, and they had seven children, as follows: Ebenezer, Benjamin, Nathaniel, Elizabeth, Mary, Kathren, Frances, and Ezra.

(III) Ezra, youngest child of Benoni and Ebenezer (Nichols) Tucker, was born in Amesbury, March 27, 1706. He married, January 24, 1727, Bathsheba Sargent, born October 10, 1709, daughter of Charles and Hannah (Foot) Sargent, of West Amesbury, near the town of Merrimack, and they had seven children: Ezra, Mary, Callia, Hittie, Sarah, and Benoni.

(IV) Ezra (2), eldest child of Ezra (1) and Bathsheba (Sargent) Tucker, settled in Henniker, New Hampshire, as early as 1766, and in 1772 purchased a place upon which he moved, and there passed his remaining days. He was a soldier at Crown Point in 1756 and 1758, in the French and Indian war, and was in the Revolution; was commissioned second lieutenant in Captain Emery's company, Colonel Thomas Stickney's regiment, March 5, 1776, and was at the battle of White Plains,

Mary Johnson was of Andover, MA, where she married Ephraim Davis. She was born about 1638, about the same time that John & Susanna Johnson were there having kids. "He is energetic, candid, well informed and very successful in his vocation." He has not changed much since then, except to improve. He is an intelligent and successful physician, a good citizen, and a cultured gentleman. He has been a member of the board of health and of the school board of Rochester for a number of years, medical referee for Strafford county, and has been United States examining surgeon since 1896. He is a Republican in politics, and has taken an active part in local political affairs, and was elected to the New Hampshire legislature in 1902, and served during the following term with credit to himself and to the satisfaction of his constituents. He has been president of the York County (Maine) Medical Association, and of the Strafford County (New Hampshire) Medical Association; is vice-president of the New Hampshire State Medical Association, and a member of the Maine Medical Association, and of the American Medical Association. He is also a member of the Free and Accepted Masons, Royal Arch Chapter, Royal and Select Masters, of Palestine Commandery, Knights Templar, of which he is a charter member; and of the Ancient Arabic Order of the Mystic Shrine. He married, November 28, 1888, Lula E. Clark, who was born March 30, 1866, daughter of Daniel G. and Frances (Chase) Clark. They have one child, Cecil Morris, born October 26, 1890.

(I) Peter Neal was a resident of Rockingham county where he raised a family.

(II) Andrew, a son of Peter Neal, removed to Vienna, Maine, where he died, March 23, 1872, aged eighty-seven years. He married Dorothy Hoyt, who was baptized April 29, 1786, one of triplets, the other two being John and Moses. Her parents were John and Dorothy (Glidden) Hoyt, of Poplin, New Hampshire. The children of this union were: Ira, John, Samuel, Andrew and Alvan, whose sketch follows.

(III) Alvan, youngest son of Andrew and Dorothy (Hoyt) Neal, was born in Vienna, April 3, 1825. He learned carpentry young, and has always followed that occupation. In 1884 he removed to Rochester, New Hampshire, and has since resided there. He married May 26, 1853, Ruth W. Bradley, who was born February 13, 1830, daughter of Alvan and Hannah (Whittier) Bradley, of Vienna, and they have had two children: Wilder B., and Carrie, who died at the age of nine.

(IV) Wilder Bradley, only son of Alvan and Ruth W. (Bradley) Neal, was born February 4, 1857, in Farmington, Maine, and was educated in the common and high schools of that town. He clerked in a grocery store there twelve years, and in 1884 removed to Rochester, New Hampshire, and opened a crockery store on North Main street, where he has since successfully carried on business. In religious faith he is a Unitarian, and is clerk and a trustee of the Unitarian Church at Rochester. He is a Republican, and has been a member of the school board four years. He is a member of Kennedy Lodge, No. 57, Independent Order of Odd Fellows, of which he is past grand, and secretary at the present time, also of Norway Plain Encampment, No. 7, and Canton Parker, No. 3.

He married, December 24, 1880, Lillian E. Bass, who was born November 10, 1859, daughter of George and Mary E. C. (Potter) Bass, of Wilton, Maine. They have three children: Carroll W., Erlon H., and Lucille R. Carroll W., born December 10, 1882, entered West Point Military Academy at seventeen, graduated at twenty-one, and was made a second lieutenant of artillery. He has spent two

years in the Philippines, and is now stationed with the Fifth Battery, at the Presidio, California. Erlon H., born October 6, 1884, graduated from the Rochester high school in 1902, and from Dartmouth College in 1906. He is now with the Title Guaranty and Trust Company of New York. Lucille, born July 30, 1887, graduated from the Rochester high school in 1906, and is now a student at Bradford Academy.

This name was originally spelled KEYSER Kezar, and was very early planted in New England. It was also identified

with the pioneer periods of central New Hampshire, and has been prominent in the annals of the town of Sutton for nearly one hundred and forty years. It means much when six generations worthily bear the name in one town.

(I) George Kezar, the emigrant ancestor of the family, was born about 1614, and was an early resident of Lynn, Massachusetts, where he was made a freeman in 1639. He was a tanner by occupation. In 1680 he removed from Lynn to Salem, and at the same time was admitted to the church in Salem by letter from the church in Lynn. He died in 1690, as indicated by the proving of his will on September 29 of that year. It was executed February 16, 1687. He married (first), Elizabeth Holyoke, daughter of Edward Holyoke. She died June 24, 1659. His second wife, Rebecca (surname unknown), survived him. His children all by the first wife, were: Eleazer, John, Benjamin, Hannah, Mary, George and Edward.

(II) John, second son and child of George and Elizabeth (Holyoke) Kezar, was a native of Lynn, whence he went with his father to Salem, and removed from that town to Haverhill, Massachusetts, in 1674. He followed the occupation of his father, and was given a parcel of land to encourage the establishment of the business in Haverhill. In 1683 a complaint was made by the good and cautious men of Haverhill against John Kezar for keeping his tan vats open, by which a few cattle and swine had been destroyed. He was a soldier in King Philip's war in 1676, and was admitted a freeman in 1677. He was killed by the Indians in the Dustin massacre, March 15, 1697. The George Kezar killed at the same time was the son of John, and not his father, as has been stated. His wife, Hannah Davis, was born December 24, 1653, daughter of John Davis and granddaughter of James Davis. Their children, born in Haverhill, were: John, George (died young), Timothy, Sarah, Mary, Eleazer, Samuel and George. The youngest George was born after the massacre.

(III) John (2), eldest child of John (1) and Hannah (Davis) Kezar, was born July 6, 1678 and resided in Haverhill. He received the tan house and yard from the estate of his father, and continued the business. In 1720 he and his wife deeded property to her mother, Mary Davis. His wife Judith, was born July 23, 1687, in Haverhill, daughter of Stephen and Mary (Tucker) Davis. They had sons, John, George and Ebenezer.

(IV) Ebenezer, youngest son of John (2) and Judith (Davis) Kezar, was born January 16, 1723, in Haverhill, and lived for a short time in Rowley, Massachusetts, whence he removed to Sutton, New Hampshire. He was past fifty years of age when he emigrated to Sutton, but he was a man of great bodily strength as well as of decided character, and was a master spirit among the early settlers. Before coming to Sutton he had been an inn-keeper, tanner

In St. George Commandery, Knights Templar, he was prelate, 1872-3-4-5-6-7-8-9-1880 and 1887; Generalissimo, 1882-3; eminent commander, 1884; and recorder from 1892 to date. Worshipful grand steward of the Grand Lodge of New Hampshire, 1898; right worthy district lecturer of Grand Lodge, 1899 and 1900; right worshipful district deputy grand master of Grand Lodge 1901-2; secretary of Aaron P. Hughes Lodge of Perfection Ancient Accepted Scottish Rite, fourteen degrees from 1897 to date; secretary of Oriental Council, Princes of Jerusalem, sixteenth degree, from 1897 to date; secretary of St. George Chapter of Rose Croix, eighteenth degree from 1897 to date; secretary of Edward A. Raymond Consistory, thirty-second degree from 1897 to date; secretary of New Hampshire Council of Deliberation, Ancient Accepted Scottish Rite, from 1897 to date; and treasurer of the Masonic Board of Relief of Nashua, from its organization, 1895, to date. Mr. Arnold married Mary Frances Taylor, daughter of John Taylor, of Nashua. Their only child, Frank Ralph Arnold, who grew to manhood in Nashua and became an electrician, died July 25, 1903. He married Lucy Samantha Crossley, and left two children: Frances Taylor and Ralph Crossley Arnold.

This name is of undoubted English origin GILL and is found in the early records of New England, where those bearing it bore no mean part in the conquering of the wilderness and in subduing a savage foe who sought to stay the march of civilization. In the struggles with the Indians the Gills were severe sufferers in common with most families of the pioneers.

(1) John Gill, of Salisbury, Massachusetts, was born about 1622, and was a husbandman or "planter" in Salisbury as early as 1646. In that year he bought a house lot and right of "commonage" of Anthony Sadler, and is listed among the "commoners" in several subsequent years. He was married May 2, 1645, in Salisbury, to Phebe, daughter of Isaac Buswell, of Salisbury. Both were members of the church in 1687. John Gill died December 1, 1690, having made his will three months previously, and it was proved at the end of March following. His children were: Elizabeth, John, Phebe, Samuel, Sarah, Moses, Benjamin and Isaac. The three eldest sons married and reared families. The first settled at Middletown, Connecticut. Samuel remained in Salisbury. Moses resided in Amesbury, where he died before March 31, 1691. His widow moved to Topsfield, Maine, her native place, and it is probable that this led to the settlement of some of her posterity in eastern New Hampshire. Samuel, son of Samuel was carried captive by the Indians to Canada when only ten years old, and never re-

turned. Tradition says he was ransomed, but refused to return to his native home. He married Rosalie James, another white captive of the tribe with whom he lived, and his son became a chief. Their descendants are now living in Canada.

(IV) The destruction of the records of the town of Newmarket has made it impossible to trace completely the line herein sought. It is known that William Gill was living in Newmarket in 1768, and that he removed thence to Concord after February, 1780. His children were: Susanna, William, Bradbury, Moses, John and Lucy, all born in Newmarket.

(V) Bradbury, second son and third child of William Gill, was born April 7, 1768, in Newmarket, New Hampshire, and was a child when taken to Concord by his father. There he grew up and was married (first) to Rebecca Straw, daughter of Jacob Straw of Hopkinton. He lived in Hopkinton, Wentworth and Salisbury, dying in the last named town (that portion which is now a part of Franklin), March 19, 1812. Rebecca (Straw) Gill died May 8, 1809, in Wentworth, and Mr. Gill married (second) Parna Baker, daughter of Abel and Polly (Howe) Baker of Concord. They had one son, who died young, and the widow married Isaac Dow of Concord. By the first wife, Mr. Gill had the following children: Moses, Lydia, Betsey, Bradbury and Rebecca. The last was born in Wentworth, New Hampshire.

(VI) Bradbury (2), second son and fourth child of Bradbury (1) and Rebecca (Straw) Gill, was born February 10, 1806, in Hopkinton, was deprived of his mother's care by death when only three years old and lost his father when six. He was reared by Samuel Knowlton of West Concord, with whom he remained until he attained his majority. He received a common school education, and acquired the trade of blacksmithing with Captain Knowlton, who was an expert at that branch of mechanics. After he became his own master Mr. Gill continued at the trade, and was long employed about Rattlesnake Hill, whose stone quarries made much demand for his labor. During one winter, Mr. Gill drove an ox-team to Concord with stone, loading back with such freight as was brought to Concord from the metropolis. During his residence in West Concord he was captain of the militia company there. About 1835 he established himself in Concord city, opening a shop in company with one Whitmarsh. This shop was located in South Main street, near Pleasant; later they dissolved partnership and Mr. Gill moved to "Mechanics' Row," which stood near the railroad track, in the rear of the present bank building, nearly opposite Park street. In course of time Mr. Gill purchased a shop which stood in what is now Capitol street, which was then private ground. When the street was opened, he moved his shop to the east side of Main street, in the rear of the present Stickney block, a little above his former location, by the railroad tracks. By his industry and shrewd investment of

DAVIE:—Edmund Davie, of Harvard College, 1674, of whom we know nothing, but what the college catalogue of 1698 tells, that he had taken his M. D. at Padua, and was then dead. Unsatisfactory conjecture may suppose that he was younger brother of Humphrey.

GEORGE DAVIE, of Sheepscoot, near Wiscasset, as early as 1653, wounded by Indians, 1676. Sullivan, 148, 298.

HUMPHREY DAVIE, of Boston, merchant, son of Sir John, who had been created a baronet, September 9, 1641, came from London 1662, possibly to encourage Rev. James Allen, freeman 1665, artillery company 1665, representative for Billerica, because he had estate there 1665-9, for Woburn 1678, probably on equal reason, an assistant 1679-86; married as second or third wife, Sarah, widow of James Richards, of Hartford, who had left large estate that caused his removal thither; had by her Humphrey and William, and died February 18, 1689. By former wife he had John, Harvard College, 1681, but whether she came with him from London, I cannot find. His widow married Hon. Jonathan Tyng.

JOHN DAVIE, of Boston, freeman May 25, 1636, a supporter of Wheelwright and Mrs. Hutchinson, punished therefor. Winthrop, I, 248. I presume he is the man admitted of the church in January before, but the Elder wrote the name DAVISSE, and called him joiner. Most of the names Davie or Davy, Davies or Davis, are convertible. He may have gone to Duxbury, where one of his name sold estate 1650.

SAMUEL DAVIE, of Boston, 1668.

A widow Mary, of Charlestown, had there baptized William, aged 13, on August 11, 1689.

DAVIS or DAVIES:—Anthony Davis, of Boston, died June, 1674, leaving widow Elizabeth.

BARNABY DAVIS, of Charlestown, 1636, or after, came in the Blessing, 1635, aged 36, died November 27, 1685, aged about 86. Frothingham, 152, has his name 1638, at division of wood and commons on Mistick side; and page 183, has Barnaby, Jr., probably his son, in the list of householders, 1678.

DANIEL DAVIS, of Kittery, 1649, freeman 1652.

DOLOR, DOLLARD or DOLLAR DAVIS, of Cambridge, 1634, is said to have married perhaps in England, Margery, sister of Simon Willard, if so, he was probably from Kent, and this conjecture is confirmed to me by collateral evidence. Yet the grave-yard at Benefield, in County Northampton, as Dr. Palfrey assures me, contains the names of his ancestors. He removed about 1640, and had land that year in Duxbury, and was of that church when he removed to Barnstable, and joined that August 27, 1648, with his wife, but had his daughter Ruth, baptized at Barnstable, March 24, 1645; was freeman of that Colony, 1646; and in the list of those able to bear arms 1643, is this man's name "and his sons." Who may be

intended by the last word, is not precisely understood, but probably John alone. Yet at the end of that list stand John and Nicholas, who might well, therefor, be thought brothers, certainly not sons. But two sons he did have, Simon and Samuel, both younger by much than John, who was executor of his will. Before removed to Duxbury, he lived some years at Concord, and was one of the proprietors of Groton, 1655, engaged in its first settlement, and made one of its selectmen by the General Court of the Colony. Still it is not likely, that he ever inhabited in the new plantation, but leaving his youngest son to reside at Concord, went back to Barnstable, and died there 1673. His daughter Ruth, married 1663, it is said, Stephen Hall; and Mary, who married June 15, 1653, Thomas Lewis, of Barnstable, was probably another.

EDWARD DAVIS, of Boston, married September 16, 1657, Hannah, daughter of Richard Gridley.

EPHRAIM DAVIS, of Haverhill, married December 29, 1660, Mary Johnson, of Andover, took oath of allegiance November 28, 1677, died 1681, leaving children Stephen, Ephraim, Thomas, Jonathan, Mary, Susanna and Hannah.

FRANCIS DAVIS, of Amesbury, swore allegiance Dec. 20, 1677.

GEORGE DAVIS, of Boston, 1644, blacksmith, perhaps the freeman of 1645, one of the founders of the second church, by wife Barbara, who had joined first church Aug., 1647, had Samuel, born October 17, 1651; and, if the records be not false, John, June 3, 1652; was a sergeant, died early in 1655. He thrived by his trade, for the inventory valued one fourth of George Munjoy's ship "Swan," and five sixteenths of Benjamin Munjoy's ship "Delight"; and his widow married January 14, 1656, John Brimblecome, first, who was one of the witnesses to his will, and for third husband Thomas Chadwell. His will made September 23, 1654, was probated April 25 following, and anticipating the marriage of his widow again, he made various provisions for the two sons. See Genealogical Register, V, 306, and IX, 35.

GEORGE DAVIS, of Lynn, freeman 1647, had Hannah, born May 31, 1650; Sarah, September 1, 1651; removed to Reading, there had Elizabeth, January 16, 1655; Mary, January 16, 1658; John, July 20, 1660; and Susanna, May 11, 1662.

GEORGE DAVIS, of Weymouth, 1654, blacksmith.

GEORGE DAVIS, of Boston, 1650, went 1654 to North Carolina, in his will before departing, provides for wife, sons Benjamin, Joseph and five daughters.

GERSHOM DAVIS, of Cambridge, had wife Sarah, who died November 20, 1713, aged 55; son Gershom, and died February 6, 1718, aged 75.

HOPEWELL DAVIS, of Charlestown, by wife Sarah, had Joseph, baptized February, 1686; Ebenezer, May 6, 1688; Sarah, November 2, 1690; Elien, January 14, 1694; and John, November 6, 1698.

ISAAC DAVIS, of Salem, 1637, of Beverly, 1650, perhaps was after at Carso; unless this were another whose eldest son John, born 1660, was living at Gloucester, 1733, with other sons Samuel and James, beside children or a daughter who married a Fitz, and was of Ipswich, and another daughter who married Smith. He had after first destruction of Falmouth, estate set out 1680, but on second destruction probably moved to safer quarters. Willis, I, 160, 209.

JACOB DAVIS, of Gloucester, married Jan. 20, 1662;

Elizabeth Bennet, had Jacob, born January 26, 1663; John, November 25, 1665, died soon; Elizabeth, June 27, 1667; Susanna, June 27, 1670; Moses, July 6, 1673; Mary, June 3, 1676; Aaron, January, 1679; and John, again, July 1, 1681.

JAMES DAVIS, of Newbury, freeman, March 4, 1635, removed to Haverhill, 1640, had wife Cicely, representative 1660, died January 19 or 29, 1679, aged 90. In his will of March 17, 1676, names as his children John, Ephraim, Samuel and Sarah, wife of John Page, Jr. His wife had died May 28, 1673.

JAMES DAVIS, of Hampton, 1638, freeman May 13, 1640. Belknap, I, 21. James, Jr., perhaps son of preceding, was of Hampton, 1643, may have lived at Haverhill, there took oath of allegiance, November 28, 1677.

JAMES DAVIS, of Boston, 1634, mariner, by wife Joanna, had Jacob, born July 11, 1639; and daughter Josebeth, Aug. 20, baptized Aug. 28, 1642, who married John Wing, of Boston; beside John, who died November 13, 1653.

JAMES DAVIS, of Plymouth, 1639, a tailor, may have been of Newport, the year before, had grant of land for serving in the Pequot War, but was gone in 1643.

JAMES DAVIS, of Boston, by wife Mary, had Mary, born May 7, 1647.

JAMES DAVIS, of Charlestown, 1658, had Elizabeth, baptized at 21 years, on May 6, 1694; and Patience, aged 18, on April 21, 1695.

JAMES DAVIS, of Haverhill, freeman 1666, was, perhaps son of James, the aged, of that town, may have married a daughter of John Eaton, of Haverhill, had son John, and died July 18, 1694.

JAMES DAVIS, of Gloucester, by wife Mehitable, who died June 9, 1666, had John, born March 10, 1660; James, March 16, 1662, died soon; James again, January 22, 1663, died soon; and Joseph, 1665, died soon. He married December 6, 1666, Elizabeth Bachelor, had Elizabeth born September 11, 1669; Abigail, April 13, 1672; Joseph again, January 25, 1674; Susanna, November 20, 1676; and Ebenezer, January 26, 1682; died 1717.

JAMES DAVIS, of Scituate, 1673, there married Elizabeth, daughter of William Randall, and removed to Boston.

JENKYN DAVIS, of Lynn, freeman March 9, 1637, a joiner, who had been in the employ of Mr. Humphrey, who unhappily, put his daughters to board with Davis, when he went to the West Indies; by Sarah, had John, and a daughter, and died 1662. Winthrop, II, 45. Lewis.

JOHN DAVIS, of Boston, 1635, a joiner, artillery company, 1643. I presume this to be the same man who came in the "Increase," 1635, aged 29; and perhaps was the John Davie, friend of Wheelwright, in the former article.

JOHN DAVIS, of Newbury, 1641, by wife Mary, had Mary, born October 6, 1642, died young; John, January 15, 1645; Zechary, February 22, 1646; Jeremy, June 21, 1648; Mary again, August 12, 1650; Cornelius, April 15, 1653; and Ephraim, September 29, 1655; and died November 12, 1675.

JOHN DAVIS, of Watertown, married Mary, daughter of John Spring, had Mary, born March 20, 1642, and probably John and Benjamin, died early, as did his widow, administration being given June 19, 1656.

JOHN DAVIS, of Reading, had John, who died November 4, 1660.

JOHN DAVIS, of York, 1650, an important person, kept an inn, freeman, probably of Massachusetts, 1652. There was also another John, perhaps his son, was lieutenant-captain, and at last sergeant-major for the Province, and deputy-president 1680-85.

JOHN DAVIS, of Boston, brother, perhaps, of Edward, a joiner, by wife Return, (daughter of Richard Gridley, married April 9, 1656), had Grace, born March 4, 1657.

JOHN DAVIS, of Roxbury, 1653, a tailor.

JOHN DAVIS, of New London, 1651-64.

JOHN DAVIS, of Charlestown, 1668, fined for hospitality to a Quaker. Frothingham, 158. He may have removed soon to Westerly, where was one John, 1669.

JOHN DAVIS, of Lynn, married October 5, 1664. Sarah, daughter of Philip Kirkland, had Sarah, born November 10, 1665, died at two months; Sarah again, February 5, 1667, died at months; Mary, July 25, 1668; Joseph, June 10, 1672, died in July of next year; John, June 16, 1674; Sarah again, February 1, 1676; Ebenezer, October 2, 1678, and Benjamin, September 27, 1681.

JOHN DAVIS, of Saco, representative 1682, "disappointed as a scandalous person," says the record.

JOSEPH DAVIS, of Kittery, 1660, constable that year, may have been son of Nicholas.

JOSEPH DAVIS, of Boston, married May 7, 1662, Elizabeth, daughter of David Saywell, freeman 1666, artillery company 1675.

JOSEPH DAVIS, perhaps of Roxbury, there married October 28, 1670, Sarah Chamberlain, but I know not, that either belong to that place. In the neighboring Joseph, of Muddy River, had Mehitable, born February 3, 1685. Possibly he may be the man named in the letter of Rev. Edmund Browne to Gov. Leverett, printed in Genealogical Register, VII, 268, as Daby.

LAWRENCE DAVIS, of Falmouth, 1662, had Rachel, born 1663; Jacob, and perhaps others; removed to Ipswich, during the first Indian war, but came back 1681, but no more is told, only that Rachel married first Robert Haynes; and second a Wedgewood, of Hampton.

NATHANIEL DAVIS, of Mass., came in the "Mary and John," or perhaps the "Hercules," having qualified himself by taking oath of allegiance and supremacy, April 16, 1634, but where he sat down I find not. See Genealogical Register, IX, 268.

NATHANIEL DAVIS, of Charlestown, 1677, had married March 31, 1675, Mary Convers, who died November 6, 1690, aged 36; and wife Mary again who died April 18, 1721, aged 65. Nathaniel, his eldest child, baptized April 19, 1677, died at Charlestown, the same year. He had also Mary, baptized May 9, 1680; Barnabus, Dec. 1681; Sarah, July 22, 1683; Zachary, August 5, 1688; and Mary, July 16, 1695; and was one of the constables 1690.

NICHOLAS DAVIS, of Charlestown, came in the "Planter," early in 1635, aged 40, with Sarah, 48, probably his wife, and Joseph, 13, perhaps his son, with four servants, whose names are then given, was in 1640 one of the promoters of the settlement of Woburn, where his wife Sarah, died May 24, 1643, and he married July 12 following, Elizabeth, widow of Joseph Isaacs; probably he removed to York, and was there in 1652. His will, of April 27, 1667, probated March 12, 1670, refers not to any son, yet opens many remote relations, or perhaps

out of fashion." He began practice in 1749. In 1755 he gives an account of the notable earthquake of November 18. In 1757, he records the event of "very cold weather." He had a case of "spotted fever" in his charge, 1761. In 1768 he records, "Points put up;" referring to early lightning rods. In 1783 he was elected a ruling elder of the North Church. In 1788 he received information from Dr. Priestly about the manufacture of saleratus.

He remembered a temporary monument to Lady Arbella Johnson, who deceased in 1630, which once stood in a later neglected cemetery in Salem. In 1801 he was interested in the new enterprise of building a turnpike. In 1827 President Adams (ex-President John Q. Adams) visited him. In 1828 the centennial of the event of his birth was observed in Salem, on August 13, by about fifty physicians, who had a public dinner in his honor, of which one has said: "Though one hundred years old he appeared among them with a firm step and a cheerful look;" and "the compliment (so intended for him) was richly deserved."

In conclusion it may be remarked that he was the son of President Edward Holyoke, of Harvard College. He was the first person on whom the degree of doctor of medicine was conferred by that college, and he afterwards received the degree of doctor of laws. He was the first president of the Massachusetts Medical Society, among the original members of the American Academy of Arts and Sciences, and at one time its president. He was at the time of his death the president of the Salem Athenaeum, the Essex Historical Society, of the Salem Savings Bank, and of the Salem Dispensary.

He was still so vigorous on his one hundredth birthday that when the morning came he rose, dressed, shaved himself without assistance, and walked to the Essex House, where the dinner was given. He published many medical articles in the reviews of his profession, and scientific papers in the "Memoirs of the American Academy of Arts and Sciences." "He possessed great repose of body and spirit, and that balance of powers which usually attends longevity."—(G. B. Loring.)

October 17, 1643, Thomas Putnam, of Salem, Massachusetts. 3. John, died in England, March 5, 1635-6, unmarried. 4. Elizur; see forward. 5. Sarah, married Andres, of Salem, Massachusetts. 6. Mary, married February 10, 1646, John Tuttle, of Rumney Marsh, Boston, Massachusetts. 7. Susanna, married —Martyn. 8. Edward, died in England, December 20, 1631, aged thirteen years.

(II) Captain Elizur Holyoke, son of Edward Holyoke (1), born at Tamworth, Warwickshire, England, died at Springfield, Massachusetts, February 6, 1676; married first, November 20, 1640, Mary Pyncheon, died October 20, 1657, daughter of William Pyncheon, of Roxbury and Springfield, Massachusetts; married second, 1658, Mrs. Editha (Stebbins-Day) Maynard, of Hartford, Connecticut. He was one of the most distinguished inhabitants of Springfield, whence he removed from Lynn; recorder of all the courts of the new county of Hampshire, captain of the military company, member of the general court, and the one from whom Mount Holyoke, on the north of Springfield, was named. Children: 1. John, born August 27, 1641, died October 8, 1641. 2. John, born September 5, 1642, died February 6, 1711-12, unmarried. 3. Hannah, born June 9, 1644, died February 1, 1677; married Samuel Talcott, of Weathersfield, Connecticut. 4. Child, born May 21, 1646, died same day. 5. Samuel, born June 9, 1647, died October 31, 1676. 6. Edward, born August 8, 1649, died June 16, 1708. 7. Elizur, born October 13, 1651; see forward. 8. Mary, born November 14, 1656, died January 14, 1678; married February 5, 1676-7, James Russell, Esq., of Charlestown, Massachusetts.

(III) Elizur Holyoke, son of Captain Elizur Holyoke (2), born at Springfield, Massachusetts, October 13, 1651, died August 11, 1711; married January 2, 1677, Mary Eliot, born October 6, 1655, daughter of Jacob and Mary (Powell-Wilcox) Eliot, of Boston, Massachusetts. He went to Boston, became a brazier; was a man of influence and wealth, and was one of the founders of the old South Church. Children: 1. Elizur, born March 28, 1679, died February, 1701. 2. Edward, born September 30, 1680, died November 30, 1680. 3. Mary, born September 1, 1681, married September 17, 1713, William Arnold, of Boston, Massachusetts. 4. John, born February 10, 1683, married January 9, 1727, Mrs. Joanna (Green) Walker. 5. Hannah, born October 12, 1685, died September 4, 1686. 6. Hannah, born February 15, 1686-7; married first, Jan-
